Talk

Appointment of chair and note-taker for the meeting

Approval of the minutes of the AGM held 9th October 2012

Constitutional Amendment

A proposal by the trustees to replace the current constitution with one acceptable to the Charity Commission so that OutStories Bristol may become Charitable Incorporated Organisation was proposed by Donald Branch and seconded by Andy Hole. The proposal was debated and adopted with the unanimous approval of those present. And, as due notice of the meeting had been given and the number present and voting was quorate for a constitutional change, the new constitution will be presented to the Charity Commission and, if accepted, replace the existing constitution on that date it is accepted. Trustees appointed today will become the first trustees under the new constitution.
